1. Information We Collect

We may collect the following types of information:


A. Personal Information You Voluntarily Provide

- Name
- Email address
- Phone number (if offered)
- Story submissions, memories, reflections, or responses to prompts
- Any additional information you choose to share with us

B. Non-Personal Information

- Browser type
- Device type
- Pages visited
- General website analytics (no personal tracking)

We **do NOT** sell or rent personal information to any third party.



2. How We Use Your Information

We use your information for the following purposes:

A. To Provide Silver Miracle Press Services

- Responding to inquiries
- Assisting with story submission
- Editing, compiling, or helping create Silver Miracle Stories, Moments, or Thoughts
- Sending requested materials or updates

B. To Preserve and Share Stories (With Permission)

You may choose one of the following options when submitting a story:

1. **Private Use Only** – Your story remains private and is returned only to you or your family.
2. **Permission to Publish** – You may grant Silver Miracle Press the right to publish your story in an anthology, digital collection, or community project.

3. **Anonymous Sharing** – You may allow your story to be included without your name or identifying details.

We will always respect your preferences.

3. Emotional Well-Being Research (IMPORTANT)

Silver Miracle Press may partner **anonymously** with:

- universities
- gerontology departments
- aging specialists
- emotional well-being researchers
- nonprofit or academic institutions

Purpose:

To explore how storytelling supports emotional connection, purpose, mental health, and the reduction of isolation among seniors and caregivers.

Your privacy is always protected.

- No identifying details are shared.
- Stories or reflections used for research are **fully anonymized**.
- Participation is **optional** and never required.

4. How We Store & Protect Your Information

We use reasonable security measures to protect your personal data against loss, misuse, or unauthorized access.

Although no online transmission can be 100% secure, we take all reasonable steps to safeguard your information.

5. Sharing Your Information

We do **not** share personal information with outside organizations unless:

- You give explicit permission to publish or share your story
- Information is anonymized for academic emotional-well-being research
- Required by law or legal request

We **do not** sell, trade, or distribute personal data for marketing purposes.

6. Your Rights

You have the right to:

- Access your information
- Request corrections
- Request deletion of your data
- Withdraw permission for story use or research participation
- Opt out of communication at any time
