

DATA SHARING & RESEARCH COLLABORATION AGREEMENT



Between:

Silver Miracle Press (“SMP”)

and

[University / Research Partner Name] (“Research Partner”)

1. Purpose of Agreement

This Agreement outlines the terms under which Silver Miracle Press will provide **fully anonymized** participant story excerpts, reflections, or questionnaire responses (“Anonymized Data”) to the Research Partner for academic, educational, or research purposes related to:

- emotional well-being
- storytelling and narrative psychology
- aging and gerontology
- caregiver experiences
- social connectedness
- mental health and isolation

All data is provided to support ethical research that aligns with the mission of Silver Miracle Press.

2. Nature of Data Provided

Silver Miracle Press may provide:

- anonymized story excerpts
- anonymized questionnaire responses
- thematic summaries
- aggregated emotional-tone analyses
- non-identifying narrative content

Silver Miracle Press will **never** provide:

- names

- addresses
 - emails
 - phone numbers
 - identifying locations
 - photos
 - raw submissions without prior anonymization
 - any material the participant has designated as private

3. Responsibilities of Silver Miracle Press (SMP)

SMP agrees to:

1. Provide only **fully anonymized data** with all identifiers removed.
 2. Maintain accurate participant permissions and opt-in/opt-out statuses.
 3. Notify the Research Partner of any concerns related to data accuracy or privacy.
 4. Ensure participants understand their participation is voluntary and anonymous.
 5. Provide documentation requested by the IRB if necessary.

4. Responsibilities of the Research Partner

The Research Partner agrees to:

1. Use the Anonymized Data for academic or research purposes only.
 2. Maintain confidentiality and data security as required by IRB and institutional policy.
 3. **Not attempt to identify, contact, or locate** any participant.
 4. Use data ethically and respectfully.
 5. Submit their own IRB application if required by their institution.
 6. Share research summaries or results with SMP upon request.
 7. Immediately inform SMP of any suspected data breach.

5. Limitations of Use

The Research Partner **may not**:

- use the data for commercial purposes
 - sell or distribute data
 - publish identifiable details
 - use the data in research unrelated to this Agreement
 - transfer data to third parties without written permission

6. Termination

Either party may terminate this Agreement with written notice.

In the event of termination:

- the Research Partner must destroy or return all Anonymized Data
- SMP is not required to provide further materials

7. Governing Law

This Agreement is governed by the laws of the **State of Florida**.
